#### **Abstract**

The present study is undertaken with the aim to understand nature, objectives and relevance of social endeavours of selected hospitals in the privage sector located in Delhi and NCR. The focus of the study is on health check-up camps from hospital and public perspective respectively. Opinion of the medical doctors is also studied with respect to social endeavours of private hospitals in order to find out how the social role of the hospitals can be made more effective. Some associations are studied and tested with chi-square test at 5% level of significance. Multivariate analysis is done with backward step-wise logistic regression. The study is based almost entirely on primary data collected by means of pre-tested and revised questionnaires for hospitals, public and doctors.
