Abstract

The BPO industry in India has emerged as one of the sectors that have provided opportunities for women to work outside their homes. The outsourcing industry has given rise to a vast range of information processing work, both to subcontracting units within a country and to those developing countries that possess a low waged computer literate workforce. The present study was undertaken with an aim to identufy challenges faced by women working in ITES at both work and family front and to explain work life balance and its various factors for women employees in ITES. While using a mix of qualitative and quantitative approaches, the study used a descriptive research design and collected information from primary sources mainly the women workers from ten BPOs- both domestic and international, in Delhi and NCR. The study has been conducted in the call centre in Delhi, Gurgoan, Noida and Faridabad as these places have around 90 percent centers. The study has included women workers (agents, representatives, executives, coach, and team leaders), their families, and their organizations in order to explore problems at work place and in their domestic life. It also explores varied types of coping mechanism adopted by these women to create a healthy work life balance.
