Abstract

Examines the nature and structure of the linguistic behaviour of children growing up in multilingual environment during the age of 2 to 3 years. Data was collected from four children over a period of several months and five recordings were done for each child. In the case of one child, the data was not sufficient. The study is thus based on the data from 3 children (i.e. 15 recordings) in the age group of 2;2 to 3;3 years. The total database consists of 2595 morphemes, 1920 words and 806 sentences.
